ARTICLE I - NAME
The name of the corporation
is

ARTICLE II - DURATION
This corporation shall have perpetual existence commencing on November 20, 1999 and
acknowledgment of these Articles or until such time as it shall be dissolved by law.

ARTICLE III - PURPOSE

ARTICLE IX - BY-LAWS



ARTICLE X


