

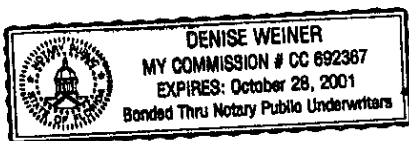
1. Douglas Love is the President of DISCOUNT RENT A CAR, INC., a Florida corporation, (hereinafter "Corporation").


