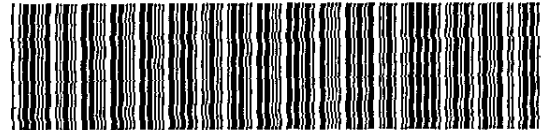

The dissolution of the Corporation was approved by the shareholders of the Corporation holding a majority of the issued and outstanding stock of the Corporation entitled to vote.


ARTICLE IV

**NOTICE OF DISSOLUTION
OF
THE BOULEVARD SALON OF NORTH FLORIDA, INC.**

This Notice of Dissolution is submitted by The Boulevard Salon of North Florida, Inc., a Florida corporation (the "Corporation"), to resolve and pay all unknown claims against the Corporation as provided in Section 607.1407, Florida Statutes.

3. The harm suffered by claimant.


