Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act (the "Act"), the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is **SOUTH FLORIDA ACCIDENT & INJURY CENTER CHIROPRACTIC PHYSICIANS, INC.** (the "Corporation"), Charter #P99000101834, filed on November 19, 1999.

2. The following Amendment to the Articles of Incorporation was adopted by the unanimous written consent of all of the Directors of the Corporation, the number of votes cast being sufficient for approval, as of April 26, 2000 in the manner prescribed by Section 607.1003 of the Act.

3. Article V of the Corporation's Articles of Incorporation is hereby deleted and replaced by a new Article V, as follows:

**"ARTICLE V"**

The affairs of the Corporation shall be managed by a Board of Directors consisting of no less than one director.
