**ARTICLES OF INCORPORATION**

I, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

**ARTICLE I**  
**NAME and PRINCIPAL OFFICE**

The name of this corporation shall be T. A. Montgomery, Inc., and the principal place of business and mailing address of this corporation shall be located at, 109 Elysium Drive, Royal Palm Beach, Florida 33411.

**ARTICLE II**  
**DURATION**

This corporation shall commence its existence as of the date of filing of the articles of incorporation, and shall exist perpetually thereafter unless sooner dissolved according to law.

**ARTICLE III**  
**PURPOSE**

The primary purpose of the business is to sell local telephone business service in the nine states covered by BellSouth and to sell Qwest long-distance business phone service in the same geographical area. However, this corporation may engage in any activity or business permitted under the laws of the State of Florida.

**ARTICLE IV**  
**CAPITALIZATION**

The capital stock authorized, and par value thereof, and the characteristics of such stock shall be as follows:

The consideration for all of the said stock shall be payable in cash, property, real or personal, labor or services in lieu of the cash, at a just valuation to be fixed by the Board of Directors of the corporation.

No shareholder shall have a pre-emptive right to purchase additional shares of the corporation's stock.

Any director individually, or any firm of which any director may be a member, may be a party to, or may be pecuniarily or otherwise interested in, any contract or transaction of this corporation, provided that the fact that such director or such firm is so interested shall be disclosed or shall have been known to the Board of Directors or a majority thereof, and any director of this corporation who is also a director or an officer of such other corporation, or who is so interested, may be counted in determining the existence of a quorum at any meeting of the Board of Directors of this corporation which shall authorize any such contract or transaction, with like force and effect as if such director were not such a director or officer of such other corporation, or not so interested.

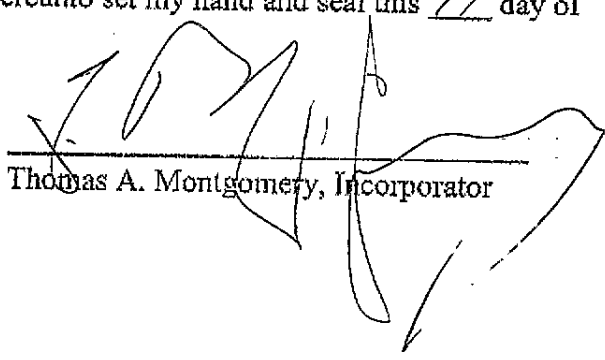
**ARTICLE IX**

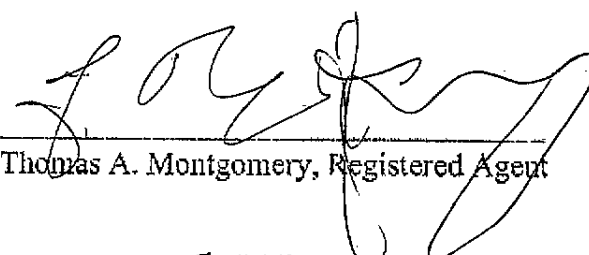
