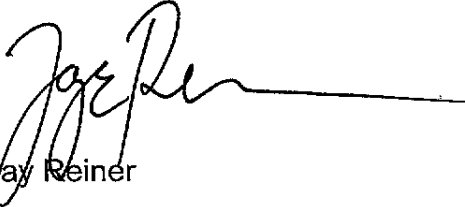

**ARTICLES OF INCORPORATION  
OF

The undersigned, acting as incorporator of **BUY-REQUEST CORP.** under the Florida Business Corporation Act, adopts the following articles of incorporation.

**ARTICLE I - NAME**

## **ARTICLE IX - BYLAWS**

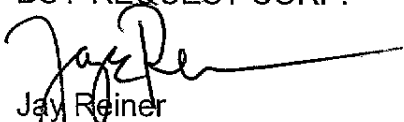
