ARTICLES OF INCORPORATION

OF

NETWORK SUPPORT GROUP, INC.

The undersigned subscriber, natural person, competent to contract for the purpose of forming a corporation under the laws of the State of Florida, does hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE ONE

NAME OF BUSINESS: The name of the proposed corporation shall be: NETWORK SUPPORT GROUP, INC.

ARTICLE TWO

NATURE OF BUSINESS. The general nature of the business to be transacted by this corporation is: Computer sales and service, including but not limited to: computer hardware, software, and accessories; repairing, upgrading, programming, and networking. The foregoing purposes and activities will be interpreted as examples only and not as limitations, and nothing therein shall be deemed as prohibiting the corporation from engaging in any lawful act or activity for which a corporation may be organized under the General Corporation Law of Florida.

ARTICLE THREE

INITIAL CAPITAL. The amount of capital with which this corporation shall begin business is Five Hundred Dollars (\$500.00).

ARTICLE FOUR




