

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be: WEATHERMAKERS ELECTRIC, INC.

The address of the principal office of this corporation shall be

corporation shall be: 4261 - 112th Terrace No., Clearwater, FL 33762.

ARTICLE II. NATURE OF BUSINESS

This corporation may engage or transact in any and all lawful activities or
business permitted under the laws of the United States, the State of Florida or any
other state, country, territory or nation.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to
have outstanding at any one time is 10,000 shares of common stock having NO par
value per share.

ARTICLE IV. REGISTERED AGENT

ARTICLE V. TERM OF EXISTENCE

This corporation is to exist perpetually.

It is the intent of the Incorporator that the corporation will qualify under Section 1244 of the Internal Revenue Code; and also that it will elect to be taxed as a subchapter S corporation (Small Business Corporation under Section 1362 of the Internal Revenue Code).


