ARTICLES OF INCORPORATION
OF
LEMVINE, INC.

Article I- Name

The name of this corporation is **LEMVINE, INC.**

Article II-Duration

This corporation shall exist into perpetuity unless sooner dissolved by law and commencing with the date of the filing of these Articles of Incorporation with the Department of State.

Article III - Purpose

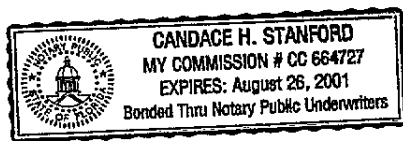
