

ARTICLES OF INCORPORATION

OF

KNOW ALL MEN BY THESE PRESENTS, that Aliyah Support Group International, Inc. desiring to establish a business corporation dedicated to the pursuit of all legal trade and commerce in the State of Florida, does hereby initiate these Articles of Incorporation according to the provisions of the Florida Business Corporation Act.

ARTICLE 1

Name

§ 1.01 The name of the Corporation shall be Aliyah Support Group International, Inc.

Principal Office and Purposes

§ 2.01 The principal place of business and mailing address of the corporation is listed herewith as follows:

§ 2.02 The purposes for which the Corporation is organized are strictly within the bounds of State and Federal requirements for business corporations.
