ARTICLES OF INCORPORATION OF LARCAM, INC.

FILED 99 NOV 23 PH 1: 20 SECRETARY OF STATE TALLAHASSEE, FLORIDA

ARTICLE I

The name of the corporation is LARCAM, INC. (the "Corporation").

ARTICLE II

The address of the principal office and the mailing address of the Corporation is 1700 Pacific Avenue, 49th Floor, Dallas, Texas 75201.

ARTICLE III

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:
