SECOND: The filing date of the articles of incorporation was: 11/5/99

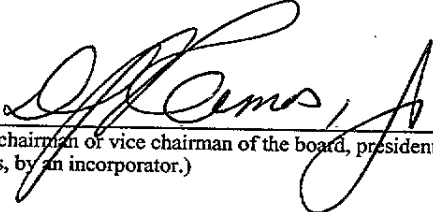
