OF Ezzy waip Transport inc. The undersigned, acting as Incorporator of a Florida corporation under the Florida Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following of Incorporation for such Corporation.

#### **ARTICLE I NAME**

Such interested director or directors may be counted in determining whether a quorum is present for the meeting at which such ratification of approval is given. If the interest of such director or directors, is, or was, necessary for the approval of such contract or transaction, then such contract or transaction shall, with disclosure of the director's or director's interest, be submitted for the approval of or ratification by the stockholders.
