ARTICLES OF INCORPORATION

The undersigned natural person, being of the age of eighteen (18) years or more, for the purpose forming. corporation under Chapter 607 of the Official Fired Statues as revised from time to time, hereby adopts the following Articles of Incorporation:

ARTICLE ONE

The name of the Corporation is: DAMARA DEVELOPMENT SYSTEMS, INC.

ARTICLE TWO

The duration of the corporation is perpetual.

ARTICLE THREE

The purposes of the Corporation are: To engage in any activities or business permitted under the laws of the United States and the State of Florida.

ARTICLE FOUR

<u>ARTICLE SEVEN</u>

The preemptive right of a shareholder to acquire additional shares is: not limited or denied.

ARTICLE EIGHT

The name and place of residence of the sole Incorporator is as follows: 467 Devils Lane, Naples. FL 34103, and the name of its initial agent at such address is: Anthony Chaudhuri.

ARTICLE NINE

The number of directors to constituting the initial board of directors of the Corporation shall be one (1) until such time as the shareholders of the Corporation change such number. The number of directors may be changed by action of the shareholders of the corporation by amending these articles, or by adoption or change of the Corporation's by-laws.
