## ARTICLES OF INCORPORATION OF Haugabook's Kiddie Klub, Inc.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

#### Article 1. Name

The name of the corporation is Haugabook's Kiddie Klub, Inc., a Florida Corporation.

#### Article 2. Duration

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department.

#### Article 3. Purpose
