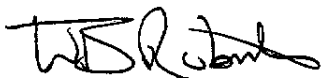

The undersigned natural person, being of the age of eighteen (18) years or more, for the purpose forming a corporation under Chapter 607 of the Official Code of Laws of Florida as revised from time to time, hereby adopts the following Articles of Incorporation:

ARTICLE ONE

The name of the Corporation is: **ARIEL DISTRIBUTING CORPORATION**

ARTICLE TWO

The duration of the corporation is **perpetual**.

ARTICLE THREE

The purposes of the Corporation are: **To engage in any activities or business permitted under the laws of the United States and the State of Florida.**

ARTICLE FOUR

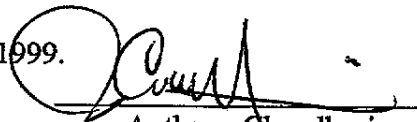

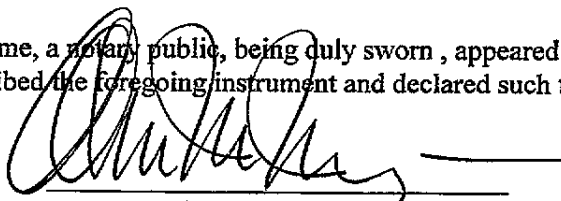
