ARTICLES OF INCORPORATION

ARTICLE I The name of this corporation shall be the Hartsaw Co. Inc.

ARTICLE II The principal place of business and the mailing address of this corporation is 3000 Walnut St. Orlando, Florida 32806.


ARTICLE III The corporation shall have the authority to issue ten shares of common stock of a par value of One Hundred Dollars per share.


ARTICLE V The purposes for which this corporation is organized is to do general business as set forth in Section 607.011 Florida Statutes and for no other purpose.


