ARTICLES OF INCORPORATION
OF
GLASSWORKS OF AMERICA, INC.

The undersigned incorporator, for the purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

- FIRST: The name of the Corporation is **GLASSWORKS OF AMERICA, INC.** (the "Corporation").
- SECOND: The principal office address and mailing address of the Corporation is **413 Oak Place, Bldg. 4C, Port Orange, Florida, 32127.**
- THIRD: The Corporation is authorized to issue 100 shares of common stock, each of which shall be without par value.
- FOURTH: The street address of the initial registered office of the Corporation is **413 Oak Place, Bldg. 4C, Port Orange, Florida, 32127**, and the registered agent at that address is **EYTON SCHLACHET.**
- FIFTH: The name and address of the incorporator of the Corporation is: **Roger D. Tiktin, 5005 Rockside Road, Suite 425, Independence, Ohio, 44131.**
- SIXTH: The Corporation expressly elects not be governed by Section 607.0901 of the Florida Business Corporation Act, as amended from time to time, relating to affiliated transactions.
- SEVENTH: The Corporation expressly elects not be governed by Section 607.0902 of the Florida Business Corporation Act, as amended from time to time, relating to control share acquisitions.
- EIGHTH: The corporate existence of the Corporation shall commence on January 1, 2000.
