The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I Corporate name

The name of the corporation is North Miami Carpet, Inc., hereinafter referred to as the "Corporation."

ARTICLE II Corporate Duration

The duration of the Corporation is perpetual, and the corporate existence is to commence upon filing hereof, pursuant to Florida Status Section 607.0203 (1991).

ARTICLE III Purpose and Powers
