ARTICLES OF INCORPORATION

for

FLORIDA KEYS NATIVE NURSERY, INC.

The undersigned, acting as incorporators of a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I. Name: The name of the corporation is FLORIDA KEYS NATIVE NURSERY, INC. The address of the corporate office shall be 171 Ojibway Avenue, Tavernier, FL 33070.

ARTICLE II. Duration: The period of this corporation's duration is perpetual.

ARTICLE III. Purpose: The purpose of this corporation is to engage in any activities or business permitted under the laws of the United States and Florida, including wholesale and retail purchase and sale of plants, and the operation of a plant nursery within and without the State of Florida.

ARTICLE IV. Capital Stock: The corporation is authorized to issue 100 shares, all of one class, at \$1.00 par value.




