ARTICLES OF INCORPORATION OF



OMNI BUILDING SERVICES, INC.

The undersigned subscribers to these Articles of Incorporation, being a natural person competent to contract, hereby forms this corporation for profit under the laws of the State of Florida.

ARTICLE I

NAME

The name of the corporation shall be OMNI BUILDING SERVICES, INC..

ARTICLE II

NATURE OF BUSINESS

The general character or nature of the business to be transacted by this corporation is to engage in activities of construction contracting, electrical contracting, home and private building inspection, drafting of construction drawings and real estate which are of an economical nature, and consistent therewith, to:

- (A) Acquire, improve and operate any real or personal property or interest or rights therein are appurtenant thereto;
 - (B) Sell, convey, assign, mortgage or lease any real or personal property;
- (C) Borrow money and to execute such evidence of indebtedness as such contracts, agreements and instruments as may be necessary, and to execute and deliver any mortgage, deed of trust, assignment of income or other security instrument in connection therewith;
- (D) Purchase the corporate assets of any other corporation and engage in the same or other character of business;
- (E) Guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of the shares of the capital stock of, or any bonds, securities, or other evidence of indebtedness created by any other corporation of the State of Florida or any other state or
