

**ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

NAME AND PRINCIPAL OFFICE

The name of this corporation is ALLSITE NETWORK DEVELOPMENT SERVICES, INC., and its principal office is located at 7950 Gulf Boulevard, Navarre Beach, Florida 32566, its mailing address is the same.

ARTICLE II

DURATION

This corporation shall exist perpetually, commencing upon the date of filing of these Articles of Incorporation.

ARTICLE III

PURPOSE

The purpose of this corporation is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV

CAPITAL STOCK

This corporation is authorized to issue 10,000 shares of \$.10 par value common

The name and address of the incorporator is EDWARD S. JANAS, 7950 Gulf Boulevard, Navarre Beach, Florida 32566.

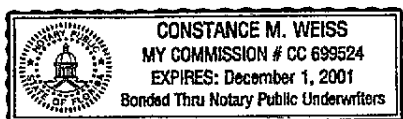
