ARTICLES OF INCORPORATION of AIRWAVE COMMUNICATIONS, INC.

<u>ARTICLE I. - NAME</u>

The name of this corporation is AIRWAVE COMMUNICATIONS, INC.

ARTICLE II. - DURATION

This corporation shall have perpetual existence, commencing on the date of execution and acknowledgment of these Articles.
