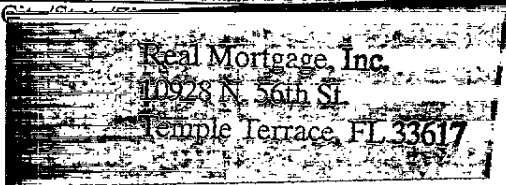

The undersigned persons hereby associate for the purpose of becoming a corporation for profit under the laws of the State of Florida in compliance with Florida Statute 607.0202.

Article I

NAME – The name of the corporation shall be SportStudy.com, Inc.

Article II

The mailing address of the principal office of the corporation shall be:

Article III

NATURE OF BUSINESS – The general nature of the business to be transacted by this corporation is to engage in Sports Instruction services, as well as any activity or business permitted under the laws of the United States and of the State of Florida.

CAPITAL STOCK – The maximum amount of capital stock of the corporation shall be One Hundred (100) shares of common stock with a par value of \$1.00 per share.

TERM OF EXISTENCE – This Corporation to exist perpetually and shall commence upon filing.

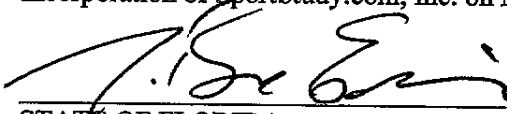

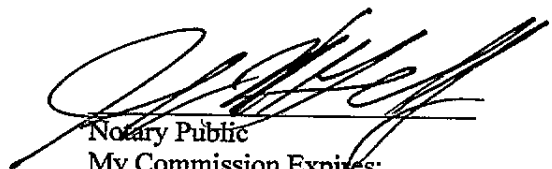
