

The undersigned, acting as Incorporator of Palm Beach Finish Carpentry, Inc., a Florida corporation (the "Corporation") under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE I

NAME

The name of the Corporation is Palm Beach Finish Carpentry, Inc. and the street address of the initial principal office of the Corporation is 6028 Forest Hill Blvd., #204, West Palm Beach, FL 33415.

ARTICLE II

PURPOSE

The Corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.


