The name of the Corporation is Interlink Financial Netlinks, Inc.

ARTICLE III

The Corporation is organized to engage in the business of providing electronic data capture and credit card processing services to merchants and to perform any and all other lawful business activities.

ARTICLE IV

The Corporation is authorized to issue 1000 shares of stock. Such shares shall be of a single class and shall have a par value of \$1.00 per share.

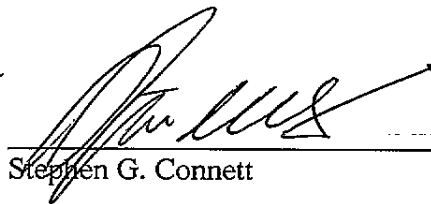
## ARTICLE IX

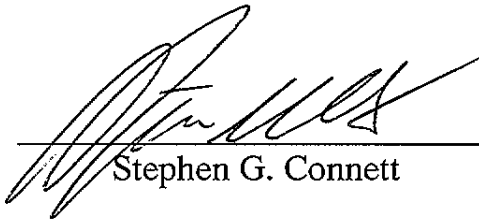
