ARTICLES OF INCORPORATION of

Manuel Regalado, M.D., P.A.

The undersigned natural person, acting hereby as Incorporator for the purpose of four a Professional Service Corporation for profit under the provisions of Chapter 607, Florida Business Corporation Act, and Chapter 621, Florida Professional Service Corporation Act, of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name of Corporation, Principal Office, and Mailing Address

The name of the corporation is:

Manuel Regalado, M.D., P.A.

The principal office and mailing address of the corporation will be 106 S.W. 10th Street. Gainesville, Florida 32601.

ARTICLE II

Purposes

The general nature and purposes of business to be transacted, promoted and carried on by the corporation are as follows:

- To engage in every aspect of the practice of medicine, and all its fields of a) specialty.
- To engage and render the professional services involved only through its officers. agents, and employees who shall be physicians in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional service as this corporation.
- To invest its funds in real estate, mortgages, stocks, bonds and any other type of investments permitted by law.
- To do everything necessary and proper in accomplishing the purposes herein set forth and to do anything incidental thereto which is not forbidden under the laws of the State of Florida.
