#### ARTICLE I - NAME

# ARTICLE IX - LAWS

The laws of the corporation shall be set forth not to carry on any other activities not permitted to be carried on by a corporation to which are deductible under Section 170 (c)(2) of the Internal Revenue Code or the corresponding Section of any future Federal Tax Code.

#### ARTICLE X – DUTIES AND POWERS

Liberty Grants, Inc., shall be a for-profit corporation and shall have all the duties and powers of profit organizations and no officer or director shall be authorized to do anything inconsistent with a profit corporation. No part of the net earnings of the corporation shall insure to the benefit of or be distributable to its members, trustees, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III. No substantial part of any of the activities of the corporation shall be carrying on the propaganda or otherwise attempting to influence legislation and the corporation shall not participate in or intervene in (including the publication or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal Income Tax under Section 501(c)(3), of the Internal Revenue Code or the corresponding Section of and future Federal Tax Code, or a corporation, contributions to which are deductible under Section 170 (c)(2) of the Internal Revenue Code, or the corresponding Section of any future Federal Tax Code.

#### ARTICLE XI - STOCK

The corporation is organized and may be operated on a stock basis within the meaning of the Florida Profit Corporation Act or if not prohibited may be issue provided by the corporation.

## ARTICLE XII - DISSOLUTION OF CORPORATION

Upon dissolution of the corporation, the assets of the corporation remaining after payment of all debts and liabilities of the corporation shall

be distributed for one or more exempt purposes within the meaning of Section 170 (c)(2) of the Internal Revenue Code or the corresponding Section of any future Federal Tax Code. All such assets not so distributed shall be disposed of by a court or competent jurisdiction of the county in which the principle office of the corporation is located, exclusively for such purposes or to such organization and organizations that the court shall deem which are organized and operated exclusively for such purpose.
