ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation.

ARTICLE I
CORPORATE NAME

The name of the Corporation is BEACON INVESTMENTS GROUP CORP., located at 11733 SW 107 Ter, Miami, Florida 33186.

ARTICLE II
INITIAL REGISTERED OFFICE


ARTICLE XI


