FOR

ROOTER CORP.

THE UNDERSIGNED, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following articles of incorporation:

ARTICLE ONE

The name of the corporation is ROOTER CORP.

The duration of the corporation is perpetual.

The general purposes for which the corporation is organized are:

1. To own and operate sewer and drain cleaning business.

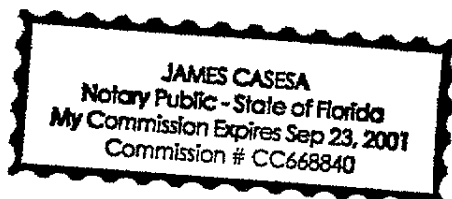


