We are hereby applying for reinstatement of the above corporation and waiver of late and/or other additional fees.


We filed the annual report in a timely manner and you accepted and cashed our \$150.00 check. While completing other annual reports this year, it was noticed that we did not receive a form for Reardon. Upon telephone inquiry, I was told that late last year it was involuntarily dissolved for "failing to file an annual report" and that a notice to that effect was sent in June 2000. The "failing to file" a report was due to an "applied for" FEI.

As grounds for reinstatement we would state the following:

- A) A report was filed and fee paid.
- B) Your rules require an FEI when "applied for" is pre-printed on report form; in this case it was not.
- C) This corporation has not engaged in any activities to date hence the lack of urgency in obtaining an FEI.
- D) I never received the aforesated June 2000 notice. As we were working with temporary help due to employee attrition at that time, I cannot state with certainty whether said notice was never received by us or, that it was received but not brought to my attention.
- E) \$150.00 filing fee and copy of last year's report with corrections for this year's report and original signatures are enclosed herewith.
