ARTICLES OF INCORPORATION

ARTICLE I

NAME OF CORPORATION

The name of this corporation is Ingram & Associates, Inc. (hereinafter called the "Corporation").

ARTICLE II

PERIOD OF DURATION

The duration of the Corporation shall be perpetual.

ARTICLE III

PURPOSES

The Corporation may engage in any activity or business permitted under the laws of the United States of America and of this State.

ARTICLE IV

AUTHORIZED STOCK

The aggregate number of shares which the Corporation shall be authorized to issue is Seven Thousand Five Hundred (7,500) shares of common stock with a par value of One Dollar (\$1.00) per share.

ARTICLE V

CAPITAL

The amount of capital with which the Corporation shall begin business shall be Five Hundred Dollars (\$500.00).

ARTICLE VI

BOARD OF DIRECTORS

The affairs of the Corporation shall be conducted by a Board of Directors composed of not less than one (1) person, who need not be a Stockholder. The number of Directors may be increased or decreased from time to time by the By-Laws adopted by the Stockholders, but shall never be less than one (1) person and none of the Directors need be Stockholders.

ARTICLE VII

INCORPORATOR

The name and address of the person signing these Articles of Incorporation is Harry E. Ingram, 111 - 5th Street, Belleair Beach, Florida 33786.

ARTICLE VIII

PRINCIPLE PLACE OF BUSINESS

The principal place of business of the Corporation shall be located at 111 - 5th Street, Belleair Beach, Florida 33786.

ARTICLE IX

REGISTERED AGENT AND REGISTERED OFFICE

The registered agent, whose address is 111 - 5th Street, Belleair Beach, Florida 33786, shall be, until otherwise designated, Harry E. Ingram.

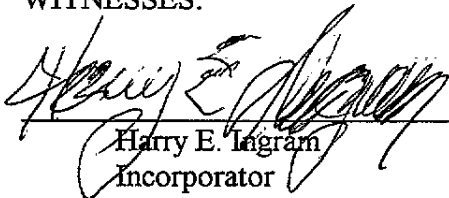
ARTICLE X

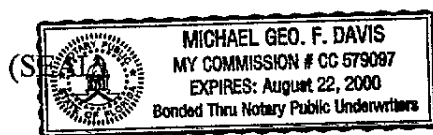

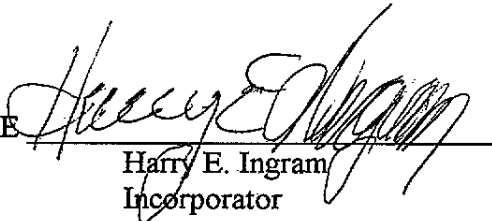

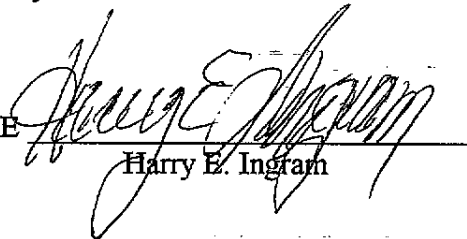
