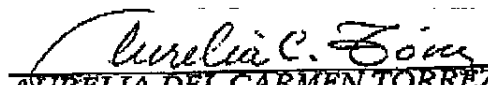
ARTICLE IX

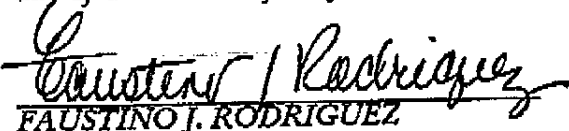

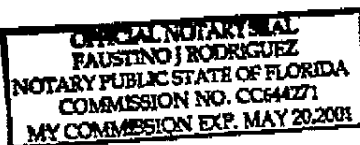

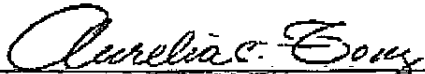
