Article I – Name

The name of the corporation is: Landis Bobcat Service, Inc.

Article II – Duration

This corporation shall exist perpetually.

Article III – Purpose

This corporation may engage in or transact any or all lawful activities or businesses permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.

Article IV – Capital Stock

This corporation is authorized to issue Seven Thousand Five Hundred (7,500) shares of One Dollar (\$1.00) par value common stock which shall be designated "Common Shares".

Article V – Preemptive Rights

The name and address of the person signing these Articles of Incorporation is: Bruce Landis, 771 North East 139th Ave., Williston, Florida 32696.


Article IX – Initial Officers

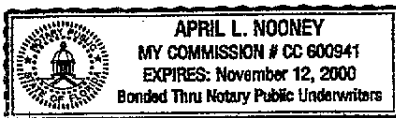
