ARTICLES OF INCORPORATION
OF
SunnySide Homes of Rockledge, Inc.

THE UNDERSIGNED, acting as sole incorporator of SunnySide Homes of Rockledge, Inc., under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name and Office

The name of the corporation shall be SunnySide Homes of Rockledge, Inc. and the corporate address shall be 7380 Sand Lake, Suite 500, Orlando, FL. 32819

ARTICLE II

Duration

The duration of the corporation is perpetual.

ARTICLE III

General Purposes
