ARTICLES OF INCORPORATION
OF

THE UNDERSIGNED, acting as sole incorporator of SunnySide Homes of Melbourne, Inc., under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name and Office

The name of the corporation shall be SunnySide Homes of Melbourne, Inc. and the corporate address shall be 7380 Sand Lake, Suite 500, Orlando, FL. 32819

ARTICLE II

Duration

The duration of the corporation is perpetual.

ARTICLE III

General Purposes

The purpose of the Corporation is to engage in any acts or activities for which a corporation may be organized under Chapter 607 of the Florida Statutes.

ARTICLE IV

Shares
