#### ARTICLES OF INCORPORATION

OF

# INSANE SOFTWARE, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person, competent to contract, hereby comes to form a corporation under the laws of the State of Florida, Florida Statutes 607.001 et. seq., and the corporation so formed shall be for profit.

# ARTICLE I - NAME, OFFICE & MAILING ADDRESS

The name of the corporation shall be: INSANE SOFTWARE, INC., located at 2803 N. Oakland Forest Drive, Apt. 105 Oakland Park, Florida 33309.

# ARTICLE II - TERM OF EXISTENCE

This corporation is to exist perpetually and shall commence at the time of filing these Articles.

# **ARTICLE III - NATURE OF BUSINESS**

The general nature of the business to be transacted by this corporation shall be computer programing and consulting within and without the United States; as well as any other business now or in the future lawful in the State of Florida or any other jurisdiction where the corporation transacts business.
