FOURTH: The date of the Amendment's adoption is February 12, 2002.

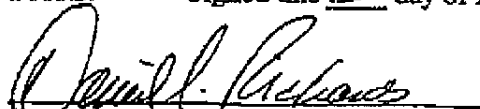
