ARTICLES OF INCORPORATION

OF

SECRETARIS STATES

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation, under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is **Better Hearing Centers of Florida, Inc.** and its principal office and mailing address is: **9915 Tamiami Trail North, Suite #2, Naples, FL 34108.**

ARTICLE II - NATURE

The nature of the business to be transacted by this corporation is: retail sales of hearing aids and medical products. To erect dwellings, apartment houses and other buildings, private or public, of all kinds, and to sell or rent the same. To lay out, grade, pave and dedicate roads, streets, avenues, highways, alleys, courts, paths, walks, parks, cemeteries and playgrounds.
