ARTICLES OF INCORPORATION

ARTICLE I

The name of the Corporation is: M C TRAVEL, INC.

Notice must be given by any shareholder to the President and the Vice-president of the Corporation, not less than twenty-four (24) hours prior to the time set for the holding of a shareholders meeting for the election of directors, that such shareholders intend to cumulate his vote at said election.
