**ARTICLE I - VIDEO OF FL, INC.**

The name of this corporation is VIDEO OF FL, INC.

**ARTICLE II - PURPOSES**

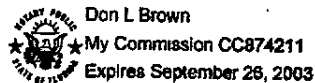


