

## ARTICLES OF INCORPORATION OF PATKOR, INC.

The undersigned incorporator, for the purpose of forming a corporation under the laws of the State of Florida, adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation is:

#### PATKOR, INC.

#### ARTICLE II - NATURE OF BUSINESS

The general character or nature of the business to be transacted by this corporation is any and all lawful business for which corporations may be incorporated under the Florida General Corporations Act.

This corporation shall have perpetual existence.
