The undersigned, acting as incorporators of a corporation pursuant to Chapter 607, Florida Statutes, adopted the following Article of Incorporation for such corporation:

ARTICLE I.

CORPORATE NAME

The name of the Corporation is PANGAEA STUDIO, INC.

ARTICLE II.

DURATION

The Duration of this Corporation is perpetual unless dissolved according to law. The Corporate existence shall commence at the date these Articles of Incorporation are filed by the Department of State of Florida.

ARTICLE III.

NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation shall be any activity or business permitted under the laws of the United States.

ARTICLE IV.

PRINCIPAL OFFICE

The principal place of business and the principal mailing address of this corporation is PANGAEA STUDIO, INC., 547 W. Carole Street, Lakeland, Florida 33803, in the County of Polk, State of Florida. The Board of Directors may from time to time, move the principal office to any other address in the State of Florida.

ARTICLE V.

CAPITAL STOCK
