To whom it may concern;

As per my telephone conversation with your reinstatement section last week concerning the reinstatement of Pal Food Corporation. When I told them my reasons for failure to file my 2000 annual report, they told me that I should write to them a letter explaining in detail the reasons for not filing on time.

When we incorporated in November of 1999, our intentions were to open a business at 3529 Dr. Martin Luther King Blvd. in Fort Myers, Florida. At first we thought that our business would be ready to open in March of this year, but to various delays due to construction, damages due theft and vandalism, we were force to open in October of this year.

During this time and knowing that we were not going to open any time soon and also knowing that the mail person would have problems distributing the mail, I called the various people or firms that I have been dealing with and informed them to send any mail to me personally in Ocala, Florida. It never occur to me at that time since I incorporated in November of 1999 that I had to renew my corporation by the first of May 2000. I sincerely believed that all permits, licenses, etc. are renewable by their anniversary dates. I spoke to my accountant who help us incorporate regarding the above filing due date and although they incorporated us they felt they were not responsible since we should have received acknowledgement letter stipulating outlining the compliance for maintaining the existence of the corporation.

I look every where, the papers that I could find was what he fax to us and that were Articles of Incorporation as it was validated by the Florida Department of State. Needless to say,

when I call him again he realize he might have not fax me this cover letter since at the time I did not need it. He apologized For not doing so and said if I need a letter from him acknowledging what had transpired to let him know. That doesn't leave much to say other than that if the letter and copy of certificate would have been mail directly to me it would have been a different matter. I honestly would have complied in sending this form on time. Unfortunately we made these honest mistakes and have taken steps that it won't happen again. I would like to request for the reasons that I state that the reinstatement fees be waived.

I'm enclosing for your review the application, along a check in the amount of \$150.00. Also is the original copy of the letter from your department mailed to my accountant's Address.

Your attention in this matter would be greatly appreciated.
