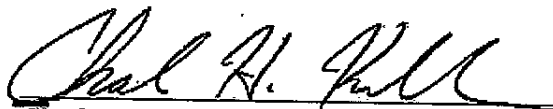
ARTICLE VII-BYLAWS

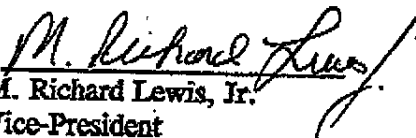
**CERTIFICATE OF DESIGNATION
