The name of the Corporation is :



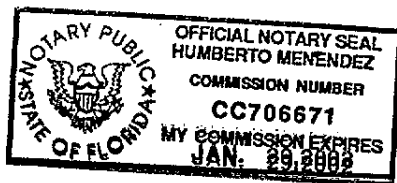


