ARTICLES OF INCORPORATION

OF

ANA INSURANCE GROUP, INC.

The undersigned hereby subscribes to these Articles of Incorporation for the purpose

of forming a corporation pursuant to the Florida General Corporation Act, Florida Statutes, Chapter

607.

ARTICLE I

NAME

The name of this corporation shall be as set forth above.

ARTICLE II

GENERAL NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this Corporation is to engage

in any and all business permitted under the laws of the State of Florida.

CAPITAL STOCK
