

**ARTICLES OF INCORPORATION



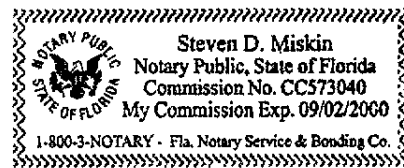
