#### **Articles of Incorporation**

of

#### e-city solutions inc.

The undersigned, acting as incorporator of e-city solutions inc. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

## ARTICLE I. NAME

The name of the corporation is e-city solutions inc.

#### ARTICLE II. ADDRESS

# ARTICLE III. COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence on the date of filing of these Articles of Incorporation.

### ARTICLE V. AUTHORIZED SHARES

The power to adopt, alter, amend or repeal bylaws shall be vested in the board of directors and the shareholders, except that the board of directors may not amend or repeal any bylaw adopted by the shareholders if the shareholders specifically provide that the bylaw is not subject to amendment or repeal by the directors.
