The undersigned, acting as incorporator of **e-city solutions inc.** under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is **e-city solutions inc.**

ARTICLE II. ADDRESS

The mailing address of the corporation is 26456 S.W. 126 Avenue, Naranja, Florida 33032.

ARTICLE III. COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence on the date of filing of these Articles of Incorporation.

ARTICLE IV. PURPOSE

The corporation is organized to engage in any activity or business permitted under the laws of the United States and Florida.

ARTICLE V. AUTHORIZED SHARES

The maximum number of shares that the corporation is authorized to have outstanding at any time is 1,000 shares of common stock having a par value of \$.01 per share.

The name and street address of the incorporator are Peter Hernandez, 1334 S.W. 8th Street, Miami, Florida 33135.


ARTICLE VIII. BYLAWS
